Custody Population refers to all offenders held in a county corrections facilities, and community residential programs under the direct supervision of those facilities. Only individuals residing in each individual sheriff's facility, or their community residential programs, count as part of the sheriff's custody population.

Supervised Population refers to all offenders who are (i) part of the custody population, (ii) part of the electronic monitoring population, (iii) who are at an Office of Community Corrections Center that is staffed by security member(s) of a sheriff's office, or (iv) who are at a halfway house or a facility operated by a sheriff's office that contracts with a state or county facility.

Community Collaboration refers to all current or former offenders who have interaction with a sheriff's office staff which cause expenditures while under the supervision of another agency or who are attending a post-release center. As most community programs do not operate on weekends or holidays, the average workday count is shown.
